4. Committee and Organizational Updates

a. HHS Staff Liaison

Pupp reported that Waukesha County received \$350,000 in American Recovery Plan Act (ARPA) funding. Community agencies will be able to bid on these funds to implement new and innovative services and get their staff trained in evidence-based practices. Requests for proposals will be released in March and agencies can apply for up to \$100,000.

The Children's Long-Term Support (CLTS) waiver program added another unit of staff to eliminate the waitlist by early spring 2023.

b. Comprehensive Community Services (CCS)

The CCS and CST teams are now comprised of 3 Mental Health Professionals, 8 Service Facilitators, a full-time Outreach Coordinator, a full-time Quality Assurance Specialist, 2 Supervisors, one Coordinator, and one Human Services Support Specialist. There are currently 2 open positions to fill before the teams are fully staffed.

CCS is working with the outreach team to establish a new process to meet weekly to ensure adequate and continuous support to families on the list for admission. This will provide the families with ongoing support, including the monthly caregiver support group, while they are waiting for admission.

Children's Intake is utilizing a new referral form within the electronic medical records to streamline the referral process.

Youth Triage is a weekly meeting to staff complex cases with urgent needs. In 2022, 47 cases were staffed. Based on these meetings, data is being collected on the trends of gender, age, substance use issues, systems involved in, and whether it is an adoption or guardianship situation. This data will be used to better track how families are being matched with services through the County. The data is currently showing that guardianship or adoption situations are at a greater need for support.

The program goal for 2022 was to serve 75 youth. The actual totals were 61 in CCS and CST combined and 12 in strictly CST for a total of 73 youth served. The goal for 2023 is to serve 150 youth. So far in 2023, there have been 7 admissions with an additional 2 pending.
