



## **Waukesha County Criminal Justice Collaborating Council Executive Committee Minutes October 11, 2021**

### **Approve Minutes from November 11, 2019 Meeting**

Motion: Farrow moved, second by Perri, to approve the CJCC Executive Committee minutes from November 11, 2019. Motion carried unanimously.

### **Discuss and Consider Marquette University Criminal Justice Data Analytics Program Student Practicum Placement for Spring 2022**

Vicki Lupo, Marquette University Associate Director of the Criminal Justice Data Analytics (CJDA) program, stated that this is the second year that the program has been in place with Marquette University.

Luczaj stated that there are many opportunities to analyze data within the CJCC programs. Luczaj would suggest the full CJCC determine projects for the student to work on, as well as have the student present at the CJCC meetings during their placement with Waukesha County. Lupo recommended that the CJCC have a data project developed for the student before the end of the year, focusing on one or two areas of focus.

### **Update on CJCC Grant Activity**

#### ***U.S. Department of Justice, Bureau of Justice Assistance (BJA) "Justice and Mental Health Collaboration Program (JMHC) FY 2019" Grant Award***

Luczaj stated that the JMHC grant implementation was delayed due to the pandemic. Waukesha County was approved for a one-year extension, allowing the grant to run through September 30, 2022. The clinical therapist who will coordinate the project has been hired. HHS staff are also working to finalize the contract with the vendor for crisis stabilization workers. The goal is to have this set up before the end of this month.

#### ***US Department of Justice, Bureau of Justice Assistance (BJA) "Comprehensive Opioid, Stimulant, and Substance Abuse Program" (COSSAP) Grant***

The grant for our Diversion program was scheduled to expire on September 30, 2021; however, Waukesha County received an extension to February 28, 2022.

#### ***WI Department of Justice "Treatment Alternatives and Diversion 2022" (TAD) Grant Application***

Luczaj distributed and reviewed a document titled, "2022 Treatment Alternatives and Diversion (TAD) Grant Application Summary."

### **Overview of 2022 CJCC Proposed Budget**

Luczaj distributed and reviewed a document titled, "2022 CJCC Proposed Budget Overview."

### **Update on Spring 2022 Stakeholder Training on Bail, EBDM, and the PSA**

Dorow stated that the CJCC will be bringing Alison Shames and Tim Schnacke back to provide an updated refresher for justice system stakeholders on bail, EBDM principles, and the PSA. There will not be court calendars during this time to provide the opportunity for judicial officers and attorneys to attend. The specific date is yet to be determined but will be on a Friday from about 9am-3pm.
