Introduction of Guests and Committee Members

Approval of Minutes – June 10, 2021

Minutes from the June 10, 2021 meeting were reviewed. Dussault moved, second by Eiring, to approve the minutes as written. Motion carried.

Current Drug Trends – Amy Miles, Forensic Toxicology Section Director at the Wisconsin State Laboratory of Hygiene

Miles presented a PowerPoint on forensic toxicology and how it aids medical and legal investigations. She explained that the role of forensic toxicology includes Drug Impaired Driving Casework (DUID) and Medical Examiner Casework. She reported on the challenges both forensics and law enforcement face including the revolving door of new drugs that surface and training. Miles reported the most common drug is alcohol but also becoming more common are benzodiazepines and synthetic benzodiazepines, stimulants, opioids and synthetic opioids, cannabis in multiple forms (vape, edibles, oils, wax), synthetic cannabinoids and inhalants.

Agency Updates

- Dussault reported the number of OWI's seen by the Sheriff's Department is averaging about 20 per 7-10 days. Crashes are remaining consistent.
- Addiction Resource Council (ARC) has been very busy with assessments.
- Wisconsin Community Services (WCS) is open for felony OWI cases and cases with extenuating circumstances.
- Waukesha County Technical College (WCTC) has held its traffic classes in person since June 2020.
 Numbers have been consistent. Online services were not offered.
