#### 2. Review and Approval of Minutes

#### 4. Discuss 2023 Community Prioritized Needs Presentation to HHS Board

The Substance Use Advisory Committee discussed adding "Recovery Housing" to the presentation. The MHAC agreed that the presentation should continue to address this issue within the community.

## 5. Committee and Organizational Updates

#### a. HHS Board Liaison Report

There is no HHS Board Liaison Report.

#### b. HHS Staff Liaison Report

Birdeau reported that Waukesha County is at the peak of budget season.

The Clinical Services Division has applied for two grants through Wisconsin DHS:

Grant #1: Received a renewed 5-year contract for the Youth Crisis Grant.
 Waukesha County will be partnering with NAMI Southeast Wisconsin. The new grant started July 1, and will allow for expanding of numerous programs, including the Youth Crisis Intervention Partners (CIP) program.

Grant #2: 3-4 year grant for regional crisis stabilization. American Rescue Plan
Act (ARPA) funds were approved to repurpose part of the Mental Health Center
(MHC) by reducing the inpatient beds from 28 beds to 16 beds this year as the
first phase of this project. The regional facility is currently scheduled to open
January 2024. The bed reduction allows the MHC to remove the Institute of
Mental Disease Designation, allowing Waukesha County to bill Medicaid for
individuals between the ages of 18 and 64.

ARPA funds are also going through the final approval stages to add three embedded crisis positions – one additional crisis worker at the Sheriff's Department, one crisis worker at the Waukesha Police Department, and one crisis worker at the Waukesha County Communications Center.

#### c. Comprehensive Community Services (CCS) Coordinating Committee

The CCS Coordinating Committee held their elections, and Jean Goodsett was re-elected as Committee Chair, and Tracy Allman was re-elected as Committee Vice Chair.

The committee continues to work on methods to increase involvement on the committee.

The CCS program's recertification on-site visit was held in June, and the program was recertified for two years.

The vendor network for CCS has added four new vendors since February that are open to youth and adults:

- Family Options (Psychotherapy)
- Power for Change (gamut of services including psychotherapy, skill development, medication management, etc.)
- Holistic Connections (equine therapy services)
- Alternatives in Psychological Consultation (skill development, wellness, peer support)

#### d. Coordinated Services Team (CST)

Altizer distributed and reviewed a flyer for a new virtual Caregiver Community group for caregivers of children and adolescents with social, emotional, behavioral, and/or mental health challenges.

#### e. Peer Specialists of Waukesha County

Austin is reaching out to agencies that utilize Peer Specialists. She hopes to revive the group next month and focus on educating employers how to best utilize the Peer Specialists.

Registration is opening tomorrow at noon for a Peer Support Specialist training in September or October for Waukesha and Milwaukee Counties.

The annual Overdose Awareness Day event will be held on August 31 at Frame Park. There will be a media/press event earlier that day.

A male Peer Support Specialist will be starting soon with the DOC.

## 6. Agency Updates / Announcements

The 2<sup>nd</sup> Annual Recovery Event with the AODA Volunteers will be held on September 17. The main event is the softball game, but there are many other activities as well.
