5. <u>Approval of May 18, 2017 Meeting Minutes</u>

## K. Carr moved to approve the minutes from the May 18, 2017 LLBMD meeting as presented. K. Trepton seconded the motion. There was no further discussion. All were in favor. Motion carried.

6. Treasurer's Report

The Treasurer's Report for July 20, 2017 was distributed to Commissioners with balances and pending checks noted. Bills paid since the last Commission meeting were noted.

#### 7. Payment Authorizations

K. Carr moved to approve the Payment Authorizations for July 20, 2017 as presented. K. Trepton seconded the motion. There was no further discussion. All were in favor. Motion carried.

#### 8. Update on the Annual Audit

Discussion took place regarding the Annual Audit. Additional information would be available at a future Commission meeting on this topic.

#### 9. Update on 2017 Goose Round-Up

The Goose Round-Up was complete. No geese were removed from Lac La Belle.

#### 10. Update on Streambank Restoration Project

K. Carr explained recent rainfalls had generated a plume of silt that entered Lac La Belle. She distributed photos showing the effects of the recent rain on the stormwater retention pond and golf course at the La Belle Golf Club. The pond did not seem to be catching the stormwater runoff in a manner that allowed the silt to be completely removed prior to entering Lac La Belle. The pond was silting in faster than originally anticipated and maintenance of the pond could be required sooner than originally anticipated. Efforts were also still required to mitigate stormwater runoff north of the Highway 16 bypass. This pond did not collect water from the creek; however, it did collect it from the farm fields that drained to the area. The area still needed additional berms and buffers along the streambank north of the bypass to assist in stormwater management. Discussion ensued regarding the history of the completed efforts in working with area farmers to reduce stormwater runoff along the stream that filtered into the retention pond. #### 11. Update on Noise/ Light Ordinances From Surrounding Municipalities

Commissioners discussed the carp boat activity that frequented Lac La Belle in the nighttime hours. While it was understood that all had rights to navigate the waters of Lac La Belle, common courtesy seemed to be lacking recently with carp boat operators shining large headlights into residences when navigating near the shoreline in an effort to catch fish. Residents had reported various instances where lights, loud music, generator noise and profanity were heard coming from the carp boats along the shoreline in the early Lac La Belle Management District Commissioners Meeting July 20, 2017 Page 4 of 6

> morning hours. Local municipalities had noise ordinances that prohibited this type of behavior. Enforcement options were discussed. It would be helpful to shield the lights or to cast them downward rather than out along the shoreline toward residences and to reduce the noise during times when people might be sleeping. Courtesy was appreciated rather than enforcement efforts. It was important for all to remember that noise and lights cast further on the lake than on land.

#### 12. Update on Boat Launch Planning Meeting

There was nothing to report on at this time.

#### 13. Update on Starry Stonewort Signage at Boat Launch

Starry Stonewort signage was available from the Clean Boats Clean Waters program. The signage was ready for placement; however, brushes and tools remained for purchase prior to installation. Additional information would be provided on the signage at the next LLBMD meeting.

#### 14. Update on 2017 Citizen Water Quality Monitoring

K. Trepton provided information related to the 2017 Citizen Water Quality Monitoring project. Monitoring of the lake in 2017 was still needed. A volunteer was needed to test the lake water, analyze data and submit results in a timely manner on an ongoing basis from April through October. Videos, instructional assistance, tools and support were offered to anyone interested in taking over the job from a dedicated lake resident with more than 30 years of experience doing this job. Anyone interested in citizen water quality monitoring should contact the LLBMD as soon as possible.

#### 15. Discuss & Act on 2017 Representative for Lake Country Community Board Meetings

K. Trepton will attend the next Lake Country Community Board meeting as an LLBMD representative.

#### 16. Discuss & Act on 2017 Shoreland Restoration Program Projects

Three applicants had come forward for the 2017 Shoreland Restoration project; however, only one wished to continue at this time.

K. Carr moved to recommend the Vande Zande project as the participant in the 2017 Shoreland Restoration Program. K. Trepton seconded the motion. There was no further discussion. All were in favor. Motion carried.

#### 17. Discuss & Act on Preliminary 2018 Budget

The Preliminary 2018 Budget was distributed to Commissioners. Discussion took place regarding the impacts to the budget for the upcoming year, noting reductions in Shoreland Restoration of \$500.00 and a reduction to the Carp Telemetry Study in the amount of \$2,500 for the upcoming year. An increase was made to the Reserves Contribution in the amount of \$2,500.

K. Carr moved to recommend the Preliminary 2018 Budget presented be amended to reduce Item #10- Shoreland Restoration to be reduced by \$500, to reduce Item #12 – Carp Telemetry Study by \$2,500 and to increase Item #13 – Reserves Contribution by \$2,500. K. Trepton seconded the motion. There was no further discussion. All were in favor. Motion carried.

The proposed 2018 budget would be included on the 2017 Annual Meeting Agenda and Budget Hearing Notice as an agenda item with approval or amendment of the proposed draft budget taking place at the Annual Meeting scheduled for Thursday, August 19, 2017 at 7:00 P.M. at the Town of Oconomowoc Town Hall.
