Kettler and Just shared information that they took away from a recent conference regarding Delta 8. Some of the information includes:

- Delta 8 is not an illegal substance
- Delta 8 is being offered in forms such as gummies and other candies
- Delta 8 causes psychosis

- Delta 8 is sold everywhere including local vape shops and vending machines
- There is no FDA control once the Delta 8 is sent to the manufacturer
- State drug testing labs do not report Delta 8
- Delta 8 is being marketed heavily in northern Wisconsin as "legal marijuana"

Gaughan stated that the HHS Board reviewed the SUAC Chair/Vice Chair/Membership appointments, had a presentation on the Aging and Disability Resource Center (ADRC), and watch a recruitment video for the Mental Health Center (MHC).

#### b. **HHS Staff Liaison**

Kettler reported that HHS has awarded four community agencies \$50,000 each to continue their prevention efforts into 2024. The funding is provided from an annual allocation from the Substance Abuse Prevention and Treatment Block Grant. The grant dictates that 20% of the funding is required to be spent on prevention. With the help of additional grants to offset costs, Waukesha County has been able to allocate approximately 80% of the grant funds to prevention efforts.

The Medical Examiner's office has released updated statistics. While 2022 still has 10 cases pending, the statistics show that drug-related deaths have decreased from previous years.
