#### **Children's Long-Term Support Waiver Renewal Initiative**

#### Opportunity for Input

The Wisconsin Department of Health Services (DHS) is planning to submit requests to the Centers for Medicare & Medicaid Services to renew the Children's Long-Term Support (CLTS) § 1915(c) home and community-based services waiver and the § 1915(b)(4) waiver.

DHS is seeking public comment on its waiver renewal applications. By law, you have the opportunity to review and comment on the CLTS waiver renewal. This ensures that the process is transparent and based on input from relevant stakeholders. Your input on the changes is important.

You may submit your comments by email or mail. Public comments are due by June 4, 2021.

The Wisconsin Department of Health Services (DHS) is planning for the renewal of the Children's Long-Term Support (CLTS) Waiver Program. The next waiver cycle, effective from 2022 through 2027, envisions the next five years of our service system for children with disabilities and their families in Wisconsin. DHS is gathering feedback from participants, families, and advocates to build this vision together.

The CLTS Waiver renewal initiative will explore modifications to the CLTS Waiver Program that require federal authority and achieve a statewide program that builds on the strength and resilience of children and families.

Every year, May celebrates Mental Health Month.


The goal of Mental Health Month is two fold:
