

# **COUNTY BOARD PROCEEDINGS**

12th Meeting, 171st Year of the Waukesha County Board of Supervisors Tuesday, February 28, 2017 Revised

## **CONVENE MEETING**

<u>Call to Order</u>: Chairman Decker called the meeting to order and led the Board in the Pledge of Allegiance and a moment of silence.

**Roll Call**: County Board Supervisors Dondlinger and Johnson notified they would not be in attendance. All other County Board Supervisors were present.

<u>County Clerk Correspondence & Announcements</u>: There were four claims filed since the last County Board Meeting. All supervisors received notifications. County Executive Farrow signed all ordinances and one resolution from the January 24, 2017 County Board meeting.

<u>Approve Minutes of Previous Meetings</u>: Supervisor Swan moved to approve the minutes from the January 24, 2017 County Board Meeting. Supervisor Paulson seconded the motion. The minutes were approved 23-0.

<u>Announcement of Votes Needed</u>: Chairman Decker announced that Ordinances 171-O-077, 171-O-078, 171-O-079, 171-O-080, and 171-O-081 required 17 votes to pass. Ordinance 171-O-082 required 19 votes. All other votes were simple majority.

Supervisor Zimmermann moved to approve Ordinance 171-O-075. Supervisor Batzko seconded the motion. The Board was polled and twenty-three (23) votes were cast "aye". The ordinance was unanimously adopted.
