## **Activities**

- Covid-19 Response Activities Continue to Dominate
- EOC operations continue in five focus teams: Testing, Contact Tracing, Data Management, Schools, and Vaccination
- Additional efforts include PIO operations and financial recovery of expenses
- Emergency Management was very involved in PPE distribution until we began conducting vaccination clinics. EM continued to coordinate with WI National Guard for testing until March 10 and worked with Public Health to develop other testing alternatives. EM has been very involved in the vaccination effort with coordinating, planning, and assisting in all the clinics.
- Vaccination clinics were conducted on 2/3, 2/4, 2/8, 2/10, 2/17, 2/24, 2/25, 3/1, 3/4, 3/10, 3/11, 3/16, 3/17, 3/18, 3/19, 3/22, 3/23, 3/24, and 3/25.
- Received the payment for the annual Hazmat Equipment Grant Reimbursement Request
- Participated in Departmental Strategic Plan development process
- Participated in recurring meetings SE Region EM, Waukesha County Healthcare Preparedness Coalition, SE Healthcare Emergency Readiness Coalition, Court Security Committee, Fire Chiefs, Police Chiefs
