## **Sex Offender Information Bulletin**

Date: May 7, 2020

The Waukesha Sheriff's Department, in cooperation with the Sex Offender Registration Committee, is releasing the following information pursuant to Wisconsin State Statutes 301.46(2m) which authorizes law enforcement agencies to inform the public of a sex offender's release when, at the discretion of the agency, the release of information will enhance public safety, awareness and protection.

The individual who appears on this notification has been convicted of a sex offense. Further, his criminal history places him in a classification level which reflects the *potential to* reoffend.

This sex offender has served the prison sentence imposed on him by the courts. The offender, under the supervision of the Department of Corrections, Division of Community Corrections, will be living in the location listed below. <u>He is not wanted by the police at this time</u>. <u>This notification is not intended</u> to increase fear; rather, it is our belief that an informed public is a safer public.

Sex offenders **have always** lived in our communities, but it wasn't until Act 440 (June 1997) that law enforcement is now able to share this information with the community. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Please understand that such abuse could potentially end law enforcement's ability to do community notifications. We believe **the only person who wins if community notification ends is the sex offender,** since sex offenders derive their power through secrecy.

Baltz was convicted in 2016, for causing child to view or listen to sexual activity 985.055(1). Baltz will be released from custody in May of 2020. He will be a LIFE REGISTRANT with the Sex Offender Registry and has submitted to face-to-face registration with law enforcement. He is to have no unsupervised contact with minors, no taverns/bars/liquor stores, no contact with victims, and not to purchase/possess or consume alcohol or illegal drugs. He is to comply with sex offender rules and will be on G.P.S. monitoring.
