
**IN THE MATTER OF:
REASSIGNING CASELOAD DUE TO
THE ROTATION OF JUDICIAL
ASSIGNMENTS IN WAUKESHA
COUNTY CIRCUIT COURT**

AMENDED ORDER

WHEREAS, pursuant to SCR 70.19(3)(a), the Chief Judge is responsible for the “assignment of judges within each judicial administrative district”;

WHEREAS, the Chief Judge of the Third Judicial Administrative District finds it in the best interests of judicial administration to modify Special Order 14-SO-14 (67);

WHEREAS, the Chief Judge of the Third Judicial Administrative District finds it in the best interest of judicial administration to rotate and reassign the caseloads of the following judges;

NOW, THEREFORE, IT IS ORDERED that, effective August 3, 2015:

1. All Civil cases previously assigned to the Honorable James R. Kieffer, Circuit Court Branch 8, including specific assignments, be reassigned to the Honorable Maria S. Lazar, Circuit Court Branch 7, in courtroom 295.
2. All Civil cases previously assigned to the Honorable Linda M. Van De Water, Circuit Court Branch 10, including specific assignments, be reassigned to the Honorable Kathryn W. Foster, Circuit Court Branch 12, in courtroom 278.
3. All Criminal cases previously assigned to the Honorable Kathryn W. Foster, Circuit Court Judge, Branch 12, including specific assignments, but excluding any ATC cases, be reassigned to the Honorable Ralph M. Ramirez, Circuit Court Branch 3, in courtroom 215.
4. All Criminal cases previously assigned to the Honorable Michael O. Bohren, Circuit Court Branch 1, including specific assignments, but excluding any PR and IN estate and trust cases, be reassigned to the Honorable Michael P. Maxwell, Circuit Court Branch 8, in courtroom 219.
5. All Family cases previously assigned to the Honorable J. Mac Davis, Branch 7, including specific assignments, be reassigned to the Honorable Michael O. Bohren, Circuit Court Branch 1, in courtroom 187.
6. All Family cases previously assigned to the Honorable Ralph M. Ramirez, Branch 3, including specific assignments, but excluding any GN guardianship cases, be reassigned to the Honorable Paul Bugenhagen, Circuit Court Branch 10, in courtroom 263.
7. All Alcohol Treatment Court cases assigned to the Honorable Kathryn W. Foster, Circuit Court Branch 12, be held in courtroom 360.

8. All PR and IN estate and trust cases will remain assigned to the Honorable Michael O. Bohren, Circuit Court Branch 1, under Special Order 13-SO-02 (67).
9. All GN guardianship cases previously assigned to the Honorable Ralph M. Ramirez, Circuit Court Branch 3, be reassigned to the Honorable Patrick C. Haughney, Circuit Court Branch 6, in courtroom 267.
