3 APPROVE APPROPRIATION OF COMMUNITY DEVELOPMENT

8 WHEREAS, the Waukesha County Board of Supervisors annually approves the allocation of
9 federal CDBG funds to various programs to meet identified community needs, and

10
11 WHEREAS specific funded projects receive monies to be loaned on a repayment basis which
12 when repaid with interest are considered Program Income, and
13

14 WHEREAS, this Program Income received for the period from August 1, 2002 to December 31,
15 2002 in the amount of \$456,863 must be revolved through the Community Development Block
16 Grant (CDBG) Program and the HOME Investment Partnership (HOME) Program for eligible
17 projects.

19 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES
20 ORDAIN that the Community Development Block Grant (CDBG) Program be authorized to use
21 \$399,488 in 2002 Program Income received as of December 31, 2002 to fund the following
22 CDBG revolving project accounts, and that the HOME Investment Partnership (HOME)
23 Program be authorized to use \$57,375 in 2002 Program Income received as of December 31,
24 2002 to fund the following HOME revolving project account as follows:

26	CDBG - Waukesha County Economic Development Corporation	\$100,000
27	CDBG - Community Housing Initiative – Housing Rehab. Program	\$164,460
28	CDBG - City of Waukesha Housing Rehabilitation Assistance Program	\$111,117
29	CDBG - Historic Preservation Fund	\$ 8,910
30	CDBG - Housing Development Fund	\$ 15,001
31	HOME Investment Partnership	\$ 57,375



36 revolving projects listed above.


