WHEREAS the County Board of Supervisors of Waukesha County finds that the proper improvement in maintenance of the above County Trunk Highway in the Village of Menomonee Falls from the Southwest corner of Section 35, Town 8 North, Range 20 East, Village of Menomonee Falls to the North one-quarter corner of Section 2, Town 7 North, Range 20 East, City of Brookfield, requires certain relocation or changes and the acquisition of certain rights of way as shown on the plat marked "Plat of Right of Way Required for C.T.H. "YY", Project I.D. 00-2782(13)(A), C.T.H. "YY", C.T.H. "K" to C.T.H. "VV", Waukesha County".



"VV, Waukesha County", said plat on file in the County Clerk's office and adopted by reference under the authority granted by Section 83.08 and Chapter 32 of the Wisconsin Statutes.
