7 WHEREAS the Southeastern Wisconsin Regional Planning Commission, duly created by the  
8 Governor of the State of Wisconsin in accordance with Section 66.945(2) of the Wisconsin  
9 Statutes on August 8, 1960, upon the petition of the Counties of Kenosha, Milwaukee, Ozaukee,  
10 Racine, Walworth, Washington and Waukesha, has the function and duty of making and  
11 adopting a Master Plan for the physical development of the region, and

13 WHEREAS the Southeastern Wisconsin Regional Planning Commission selected and adopted on  
14 July 12, 1979, a report entitled "Regional Water Quality Management Plan for Southeastern  
15 Wisconsin-Year 2000", (Southeastern Wisconsin Regional Planning Commission Report No.  
16 30), and

18 WHEREAS the Waukesha County Board of Supervisors has supported, participated in the  
19 financing of, and generally concurred in the Regional Planning Programs undertaken by the  
20 Southeastern Wisconsin Regional Planning Commission and believes that the Regional Water  
21 Quality Management Plan for the Southeastern Wisconsin Region is a sound and valuable guide  
22 providing technical data and support to the concept of further refinement of the adopted Regional  
23 Land Use Plan, and

25 WHEREAS the County Board of Supervisors has adopted the "Regional Water Quality  
26 Management Plan for Southeastern Wisconsin - Year 2000", Planning Report No. 30 on October  
27 23, 1979 in Resolution No. 140, and  
28

29 WHEREAS the City of Pewaukee requested on March 20, 2002, an amendment to the Adopted  
30 Regional Water Quality Management Plan (Pewaukee Sanitary Sewer Service Area), to remove  
31 certain land from the Pewaukee Sanitary Sewer Service Area, and the City of Waukesha  
32 requested on February 25, 2002 and April 4, 2002, an amendment to the Adopted Regional  
33 Water Quality Management Plan (Waukesha Sanitary Sewer Service Area), to add certain lands  
34 to the Waukesha Sanitary Sewer Service Area and, whereas the report entitled, "Amendment to  
35 the Regional Water Quality Management Plan for the City of Pewaukee and the City of  
36 Waukesha, Waukesha County, Wisconsin", dated June 2002, was proposed and a Plan  
37 amendment was adopted by the Southeastern Wisconsin Regional Planning Commission on June  
38 19, 2002.

40 WHEREAS the subject matter of this Resolution has been duly considered by the Waukesha  
41 County Park and Planning Commission and the Land Use, Parks and Environmental Committee,  
42 which recommends its adoption.

45 THE COUNTY OF WAUKESHA that the report entitled "Amendment to the Regional Water

Said amendment to the regional water quality management plan pertains to the revised Pewaukee and Waukesha sanitary sewer service areas and consists of the documents attached hereto and made a part hereof. RESOLUTION NO. 2002-07

RESOLUTION OF THE SOUTHEASTERN WISCONSIN REGIONAL PLANNING COMMISSION AMENDING THE ADOPTED REGIONAL WATER QUALITY MANAGEMENT PLAN, THAT PLAN BEING A PART OF THE MASTER PLAN FOR THE PHYSICAL DEVELOPMENT OF THE REGION CONSISTING OF THE COUNTIES OF KENOSHA, MILWAUKEE, OZAUKEE, RACINE, WALWORTH, WASHINGTON, AND WAUKESHA IN THE STATE OF WISCONSIN (PEWAUKEE AND WAUKESHA SANITARY SEWER SERVICE AREAS)

WHEREAS, pursuant to Section 66.0309(10) of the *Wisconsin Statutes*, the Southeastern Wisconsin Regional Planning Commission, at a meeting held on the 12th day of July 1979, duly adopted a regional water quality management plan as documented in the three-volume SEWRPC Planning Report No. 30, *A Regional Water Quality Management Plan for Southeastern Wisconsin: 2000*; and

WHEREAS, at a meeting held on the 17th day of June 1985, the Commission duly adopted an amendment to the regional water quality management plan refining and detailing the Pewaukee sanitary sewer service area as documented in SEWRPC Community Assistance Planning Report No. 113, *Sanitary Sewer Service Area for the Town of Pewaukee Sanitary District No. 3, Lake Pewaukee Sanitary District, and Village of Pewaukee, Waukesha County, Wisconsin*, June 1985, as amended; and

WHEREAS, at a meeting held on the 3rd day of March 1999, the Commission duly adopted an amendment to the regional water quality management plan refining and detailing the Waukesha sanitary sewer service area as documented in SEWRPC Community Assistance Planning Report No. 100 (2nd Edition), *Sanitary Sewer Service Area for the City of Waukesha and Environs, Waukesha County, Wisconsin*, March 1999, as amended; and

WHEREAS, by letter dated March 20, 2002, the City of Pewaukee requested that certain lands be removed from the Pewaukee sanitary sewer service area and added to the Waukesha sanitary sewer service area based on gravity flow design-level analyses and in accordance with a 1997 boundary agreement between the Cities of Pewaukee and Waukesha; and

WHEREAS, by letter dated February 25, 2002, the City of Waukesha requested that the Commission amend the Waukesha sanitary sewer service area to attach to that area the Kettle Moraine High School located in the Village of Wales for the purpose of accepting holding tank wastes from the Kettle Moraine High School at the Waukesha sewage treatment plant; and

WHEREAS, by letter dated April 4, 2002, the City of Waukesha requested that the Commission amend the Waukesha sanitary sewer service area to attach to that area a proposed restaurant located at the intersection of STH 83 and STH 59 in the Town of Genesee for the purpose of accepting holding tank wastes from that site at the Waukesha sewage treatment plant; and

WHEREAS, the provisions of NR 113 of the Wisconsin Administrative Code require that holding tank systems designed to accept at least 3,000 gallons of waste per day be attached to a sewer service area of a public sewage treatment facility; and

WHEREAS, the Kettle Moraine High School and the proposed restaurant each require holding tank systems to accommodate flows in excess of 3,000 gallons of waste per day; and

WHEREAS, the proposed amendment to the regional water quality management plan is documented in a Commission staff memorandum entitled, "Response to Requests by the City of Waukesha and the City of Pewaukee to Amend the Waukesha and Pewaukee Sanitary Sewer Service Areas," attached hereto and made a part hereof; and

WHEREAS, Section 66.0309(9) of the *Wisconsin Statutes* authorizes and empowers the Regional Planning Commission, as the work of making the whole master plan progresses, to amend, extend, or add to the master plan or carry any part or subject thereof into greater detail;


NOW, THEREFORE, BE IT HEREBY RESOLVED:

FIRST: That the regional water quality management plan for the Southeastern Wisconsin Region, being a part of the master plan for the physical development of the Region and comprised of SEWRPC Planning Report No. 30, Volumes One, Two, and Three, which was adopted by the Commission as a part of the master plan on the 12th day of July 1979, and which was amended on the 17th day of June 1985 to include the refined Pewaukee sewer service area, as set forth in SEWRPC Community Assistance Planning Report No. 113 as amended; and which was also amended on the 3rd day of March 1999 to include the refined Waukesha sewer service area, as set forth in SEWRPC Community Assistance Planning Report No. 100 (2nd Edition) as amended, be and the same hereby is amended in the manner identified on Map 1 of the aforereferenced SEWRPC staff memorandum.

SECOND: That the Executive Director is authorized to submit findings to the Wisconsin Department of Natural Resources and the Wisconsin Department of Commerce that the holding tanks necessary to serve the Kettle Moraine High School in the Village of Wales and the proposed restaurant in the Town of Genesee, along with the transfer of territory from the Pewaukee sewer service area to the Waukesha sewer service area, are in conformance with, and would serve to implement, the adopted regional water quality management plan as herein amended.


THIRD: That a true, correct, and exact copy of this resolution, together with the aforereferenced SEWRPC staff memorandum, shall be forthwith distributed to each of the local legislative bodies of the local governmental units within the Region entitled thereto and to such other bodies, agencies, or individuals as the law may require or as the Commission, its Executive Committee, or its Executive Director, at their discretion, shall determine and direct.

## SEWRPC STAFF MEMORANDUM

### RESPONSE TO REQUESTS BY THE CITY OF WAUKESHA AND THE CITY OF PEWAUKEE TO AMEND THE WAUKESHA AND PEWAUKEE SANITARY SEWER SERVICE AREAS

#### INTRODUCTION AND BACKGROUND

During February-April 2002, the Southeastern Wisconsin Regional Planning Commission received several requests to amend the Waukesha and Pewaukee sanitary sewer service areas. The Waukesha sewer service area plan is currently documented in SEWRPC Community Assistance Planning Report No. 100 (2nd Edition), *Sanitary Sewer Service Area for the City of Waukesha and Environs*, dated March 1999, as amended. The Pewaukee sewer service area plan is currently documented in SEWRPC Community Assistance Planning Report No. 113, *Sanitary Sewer Service Area for the Town of Pewaukee Sanitary District No. 3, Lake Pewaukee Sanitary District, and Village of Pewaukee*, dated June 1985, as amended. The purpose of the requested amendments would be: 1) to transfer certain lands currently in the Pewaukee sewer service area to the Waukesha sewer service area; and 2) to include in the Waukesha sewer service area two outlying sites that are to be served by large holding tanks.

#### THE PROPOSED AMENDMENTS

##### **Transfer of Land from the Pewaukee Sewer Service Area to the Waukesha Sewer Service Area**

The proposed transfer of land from the Pewaukee sewer service area to the Waukesha sewer service area represents a refinement of the boundary between those sewer service areas based upon gravity flow design-level analyses. The amendment was initiated by the City of Pewaukee Department of Public Works in a letter to the Regional Planning Commission dated March 20, 2002. The proposed amendment was subsequently endorsed by the City of Waukesha and the City of Brookfield.

Under this proposal, two areas located in the northwest quarter of U.S. Public Land Survey Section 30, Township 7 North, Range 19 East, would be transferred from the Pewaukee service area to the Waukesha service area (see Map 1). The areas would be connected to the Waukesha sewerage system on a gravity flow basis.


The areas proposed to be transferred from the Pewaukee sewer service area to the Waukesha sewer service area together encompass 25 acres of residential land, and include 22 existing dwelling units currently served by onsite sewage disposal systems. There is no developable land within the subject area for additional dwelling units. The proposed amendment would have a negligible impact on the population levels and overall size of the Waukesha and Pewaukee sewer service areas.

Replacing onsite sewage disposal systems with centralized sewer service may be expected to reduce the pollutant loadings from existing onsite disposal systems to surface and ground waters.

##### **Addition of Sites Served by Large Holding Tanks to the Waukesha Sewer Service Area**


In letters to the Commission dated February 25, 2002, and April 4, 2002, the City of Waukesha also requested the inclusion of two outlying sites—the Kettle Moraine High School in the Village of Wales and a restaurant to be located near the intersection of STH 59 and STH 83 in the Town of Genesee—in the Waukesha sewer service area in order to enable the conveyance of wastewater from holding tanks at these sites to the Waukesha sewerage system for treatment and disposal. The request is in compliance with Chapter NR 113 of the *Wisconsin Administrative Code*, which requires that holding tank systems designed to accept 3,000 gallons or more of waste per day be attached to a sewer service area of a public sewage treatment plant which has contracted to accept the waste. The City of Waukesha has agreed to accept wastewater conveyed from these sites.

The need for a holding tank system to serve Kettle Moraine High School was precipitated by a substantial expansion of the school. The school was previously served by an onsite sewage disposal system.

The site of the proposed restaurant in the Town of Genesee is part of a relatively small, developing commercial node near the intersection of STH 83 and STH 59 in the Town. Currently developed commercial uses in the immediate area are served by onsite sewage disposal systems, whereas the restaurant will generate a quantity of wastewater that could not be adequately treated by such systems. Development of a small commercial node at the intersection of STH 83 and STH 59 is envisioned in the Waukesha County development plan.

#### SEWAGE TREATMENT PLANT CAPACITY ANALYSIS

The City of Waukesha sewage treatment facility, which was upgraded and expanded in 1994, has a design hydraulic loading capacity of 14.0 million gallons per day (mgd) on an average annual flow basis. The average annual flow rate in 2001 was less than 10.0 mgd. The anticipated sewage flow to be generated from the areas proposed to be added to the Waukesha sewer service area is expected to be about 0.04 mgd on an average annual basis. The sewage treatment plant has specific provisions for accepting septage and holding tank wastes. Thus, the existing treatment plant should have adequate capacity to treat sewage flows from the amended sewer service area.

#### CONCLUDING RECOMMENDATIONS

Based upon the foregoing, it is recommended that the Southeastern Wisconsin Regional Planning Commission formally amend the sanitary sewer service areas for the Pewaukee and Waukesha areas as documented in SEWRPC Community Assistance Planning Reports No. 113 and No. 100 (2nd Edition), as amended, in the manner identified on Map 1. A more detailed delineation of the revised sewer service areas located in the northwest quarter of U.S. Public Land Survey Section 30, Township 7 North, Range 19 East, and of the environmentally significant lands within, is shown on an aerial photograph reproduced as Map 2.


