3 ADOPT THE WAUKESHA COUNTY TRANSIT SYSTEM DEVELOPMENT PLAN: 2002-  
4 2006 (SEWRPC COMMUNITY ASSISTANCE PLANNING REPORT No. 245)

7 WHEREAS in May 1997, Waukesha County requested that the Southeastern Wisconsin  
8 Regional Planning Commission (SEWRPC) assist in preparing a public transit system  
9 development plan for the County's transit system which would identify operating improvements  
10 needed to provide continued and improved transit service to Waukesha County during the period  
11 2002-2006, and  
12

13 WHEREAS a Waukesha County Public Transportation Planning Advisory Committee was  
14 created in August 1998 to assist in the preparation of such a plan, which Committee consisted of  
15 knowledgeable and experienced representatives from local and state agencies concerned with  
16 transportation system development, local elected officials, and representatives of local business  
17 and industry, and

19 WHEREAS under the guidance of the Advisory Committee, all research and analyses  
20 undertaken for the preparation of the Waukesha County transit system development plan have  
21 been concluded, including the preparation of SEWRPC Community Assistance Planning Report  
22 No. 245, Waukesha County Transit System Development Plan: 2002-2006, published in  
23 November 2001, which report contains specific recommendations as to operation and funding of  
24 the recommended public transit services, together with descriptive and explanatory matter and  
25 other matter intended to constitute a refinement and amendment of the transit element of the  
26 adopted regional transportation system plan for the year 2020, and

28 WHEREAS the Advisory Committee approved the Waukesha County Transit System  
29 Development Plan: 2002-2006 at its meeting held on November 27, 2001, and recommended that  
30 the Waukesha County Board of Supervisors and the Southeastern Wisconsin Regional Planning  
31 Commission act favorably upon the plan.


33 NOW THEREFORE BE IT HEREBY RESOLVED BY THE WAUKESHA COUNTY BOARD
