7 WHEREAS Waukesha County owns and operates a system of County highways, and

9 WHEREAS Wisconsin Statutes permit the County to regulate parking on County highways, and

11 WHEREAS the County has and continues to adopt Ordinances which regulate the location and
12 nature of prohibitions of parking along County highways, and

14 WHEREAS it may be necessary due to unique or unusual circumstances to temporarily suspend
15 those regulations, and



17 WHEREAS it is appropriate to have in place a mechanism to allow such temporary suspension
18 of parking regulations.

20 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES
21 ORDAIN that the County Sheriff and every city, village and town Police Chief is authorized to
22 temporarily suspend any County parking regulation during those times and circumstances that
23 require suspension for legitimate reasons of law enforcement or traffic regulation.

25 BE IT FURTHER ORDAINED that such suspension shall not exceed twenty-four (24)
26 consecutive hours at any one location.
