
13 WHEREAS Waukesha County requests financial assistance from the Department of Natural


19 WHEREAS the DNR requires applicants to merge the authorizing resolutions for the Recycling


22 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS


