3 CHANGE IN BUDGET INTENT FOR PUBLICATION OF PUBLIC OFFICIAL  
4 DIRECTORIES

6 WHEREAS the current County Clerk was not involved in the Waukesha County 2003 budget  
7 process, and

8  
9 WHEREAS the previous County Clerk discontinued the publishing of public official directories  
10 in 2002 and made the same information available on the County Clerk's web page, and

11  
12 WHEREAS, with exception of 2002, the Waukesha County Clerk has been publishing the  
13 public official directory since 1918, and

14  
15 WHEREAS all of the counties in the state with the exception of Waukesha County currently  
16 publish a public official directory, and

17  
18 WHEREAS the County Clerk has had numerous requests to publish the small public official  
19 directories by residents without access to a computer, local officials, and county departments,  
20 and

21  
22 WHEREAS the County Clerk has found a way to have the purchaser, not the county, cover the  
23 cost of publishing the directories by having the purchaser order and pre-pay before the directory  
24 is published to ensure that only the amount of directories ordered and paid for would be printed.

25  
26 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS  
27 that the 2003 budget is amended by deleting the last sentence of Program Highlights on page 337  
28 to allow for the County Clerk to publish the public official directories, and receive the revenue.

29  
30 BE IT FURTHER ORDAINED that the revenue account 9903 be used for revenue created by the  
31 selling of public official directories.


