

ENROLLED ORDINANCE 159-127

DISPOSE OF BUILDING AT 1120 NORTHVIEW ROAD

WHEREAS Waukesha County has acquired certain residential structures in the past which were incidental to land acquisition, and

WHEREAS the County acquired a residential structure at 1120 Northview Road in this way, and

WHEREAS the County converted this structures to a rental unit, and

WHEREAS the structure at 1120 Northview Road has been inspected and found to contain mold, and

WHEREAS the removal of said mold is estimated to cost in excess of \$10,000, and

WHEREAS renting out residential structures is not a core business for County government.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the Department of Public Works is authorized to dispose of the structure at 1120 Northview Road by first offering the structure for sale and removal; however, if no interest in purchasing the structure is expressed, then the alternative of razing the building is authorized.
