

ENROLLED ORDINANCE 159-35

ESTABLISHMENT OF SPEED ZONE
COUNTY TRUNK HIGHWAY "E"

WHEREAS Wisconsin Statutes permit local authorities to establish speed zones within certain guidelines, and

WHEREAS a traffic engineering study has been made to determine the safe travel speed for all vehicles upon C.T.H. E in the Town of Eagle.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the speed zone on C.T.H. E is modified as follows:

1. Rescind the speed limit of fifty-five (55) miles per hour on C.T.H. E from its intersection with South Shore Drive southerly to the Waukesha County line.
2. Establish a forty-five (45) mile per hour speed zone on C.T.H.E from its intersection with South Shore Drive southerly to the Waukesha County line.

BE IT FURTHER ORDAINED that this declaration rescinds all previous restrictions for the above described portion of the County Trunk Highway System.
