PARKING REGULATION – CTH Y

WHEREAS Section 349.13 of the Wisconsin Statutes provides that local authorities may regulate the parking, standing and stopping of vehicles along highways under their jurisdiction.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the following parking regulation shall be in effect upon the placement of proper signs:


Both sides of CTH Y from Wynfield Road northerly to a point 2500 feet north of Wynfield Road within the City of Brookfield Corporate Limits – No Parking Anytime.

BE IT FURTHER ORDAINED that this declaration rescinds all other previous restrictions for the above described portion of the County Trunk Highway System.






