

ENROLLED ORDINANCE 160-41

AMEND THE TEXT OF THE TOWN OF MUKWONAGO ZONING ORDINANCE
BY AMENDING THE DEFINITION OF OFFSET, SETBACK AND OVERHANG
AND PROVIDING A SPECIAL EXCEPTION PROCEDURE FOR
ACCESSORY STRUCTURES (ZT-1580)

WHEREAS the subject matter of this Ordinance having been approved by the Mukwonago Town Board on July 20, 2005, after Public Hearing and the giving of requisite notice of said hearing, and duly referred and considered by the Waukesha County Park and Planning Commission and a recommendation thereon reported to the Land Use, Parks and Environment Committee and the Waukesha County Board of Supervisors as required by Section 60.61 of the Wisconsin Statutes.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the Ordinance amending the text of the Town of Mukwonago Zoning Ordinance, approved by the Mukwonago Town Board on May 9, 1983, to amend the definition of offset, setback and overhang and provide a special exception procedure for accessory structures, and more specifically described in the "Staff Report and Recommendation" on file in the office of the Waukesha County Department of Parks and Land Use and made a part of this Ordinance by reference (ZT-1580), is hereby approved.


BE IT FURTHER ORDAINED that the Waukesha County Clerk shall file a certified copy of this Ordinance with the Town of Mukwonago.


BE IT FURTHER ORDAINED that the Ordinance shall be in full force and effect upon passage, approval and publication.


BE IT FURTHER ORDAINED that all Ordinances inconsistent with or with contravention of provisions of this Ordinance are hereby repealed.


