

ENROLLED ORDINANCE 160-81

APPROPRIATE STATE OF WISCONSIN DIVISION OF PUBLIC HEALTH WOMEN, INFANT  
AND CHILDREN NUTRITION PROGRAM GRANT FUNDING TO THE WAUKESHA  
COUNTY DEPARTMENT OF HEALTH AND HUMAN SERVICES

WHEREAS, nutrition related health programs continue among Waukesha County infants, children and pregnant women, and

WHEREAS, the Women, Infant and Children Program (WIC) provides nutritional prescriptions and monetary food vouchers to resolve these current or potential nutrition related health problems, and

WHEREAS, the parent and child enrollment continues to increase from 2,120 per month to 2,223 per month, and

WHEREAS, the State of Wisconsin Division of Public Health recognizes the Waukesha County 2005 WIC Program enrollment increase and is providing an allocation increase of \$18,828 for a total of \$327,552, to offset associated on call staff salaries and supplies, and


WHEREAS, the 2005 budget for WIC appropriated \$310,000 of anticipated funding, this ordinance seeks to modify the budget by \$17,552 to equal the \$327,552 of state funding.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the Department of Health and Human Services, Division of Public Health be authorized to expend the additional funds allocated for the Women, Infant and Children Program by the State of Wisconsin, Department of Health and Family Services, Division of Public Health.

BE IT FURTHER ORDAINED that the 2005 Department of Health and Human Services, Public Health Division budget be modified by increasing general government revenues by \$17,552 and increasing the operating expense appropriations by \$9,869, personnel cost appropriations by \$5,124 and interdepartmental charge appropriations by \$2,559 for Women, Infant and Children Program expenditures.


