

ENROLLED RESOLUTION 160-3

AMEND THE REGIONAL WATER QUALITY MANAGEMENT PLAN FOR THE  
VILLAGE OF MUKWONAGO, WAUKESHA COUNTY, WISCONSIN

WHEREAS the Southeastern Wisconsin Regional Planning Commission, duly created by the Governor of the State of Wisconsin in accordance with Section 66.945(2) of the Wisconsin Statutes on August 8, 1960, upon the petition of the Counties of Kenosha, Milwaukee, Ozaukee, Racine, Walworth, Washington and Waukesha, has the function and duty of making and adopting a Master Plan for the physical development of the region, and

WHEREAS the Southeastern Wisconsin Regional Planning Commission selected and adopted on July 12, 1979, a report entitled "Regional Water Quality Management Plan for Southeastern Wisconsin-Year 2000", (Southeastern Wisconsin Regional Planning Commission Report No. 30), and

WHEREAS the Waukesha County Board of Supervisors has supported, participated in the financing of, and generally concurred in the Regional Planning Programs undertaken by the Southeastern Wisconsin Regional Planning Commission and believes that the Regional Water Quality Management Plan for the Southeastern Wisconsin Region is a sound and valuable guide providing technical data and support to the concept of further refinement of the adopted Regional Land Use Plan, and

WHEREAS the County Board of Supervisors has adopted the "Regional Water Quality Management Plan for Southeastern Wisconsin – Year 2000", Planning Report No. 30 on October 23, 1979 in Resolution No. 140, and

WHEREAS the Southeastern Wisconsin Regional Planning Commission and the Village of Mukwonago adopted an amendment to the "Regional Water Quality Management Plan" refining and detailing the Mukwonago Sewer Service area documented as Community Assistance Planning Report No 191, and entitled "Sanitary Sewer Service Area for the Village of Mukwonago, Waukesha County, Wisconsin" dated November 1990 as amended; and

WHEREAS the Village of Mukwonago requested on January 26, 2005, an amendment to Community Assistance Planning Report No. 191, to add certain land to the Village of Mukwonago Sanitary Sewer Service area, and after due notice and public hearing held on February 15, 2005, and preparation of a report entitled, "Regional Water Quality Management Plan for the Village of Mukwonago, Waukesha County, Wisconsin", dated March 2005, by the Southeastern Wisconsin Regional Planning Commission adopted said amendment on March 2, 2005, and the Village of Mukwonago Board of Trustees adopted said amendment on February 15, 2005, and

WHEREAS the subject matter of this Resolution has been duly considered by the Waukesha County Park and Planning Commission and the Land Use, Parks and Environmental Committee, which recommends its adoption.

NOW THEREFORE BE IT RESOLVED BY THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA that the Southeastern Wisconsin Regional Planning Commission's Planning Report No. 30, Regional Water Quality Management Plan for Southeastern Wisconsin – Year 2000, as amended in Community Assistance Planning Report

No. 191 entitled “Regional Water Quality Management Plan for the Village of Mukwonago, Waukesha County, Wisconsin” dated March 2005, is hereby approved signifying the County’s agreement with the change to the “Regional Water Quality Management Plan” identified in the amendment document.

BE IT FURTHER RESOLVED that the Waukesha County Clerk shall transmit a certified copy of this Resolution to the Southeastern Wisconsin Regional Planning Commission and the Mukwonago Village Clerk upon its adoption.
