ACCEPT EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE PROGRAM 2005
GRANT AWARD AND MODIFY WAUKESHA COUNTY SHERIFF DEPARTMENT'S
2006 BUDGET TO AUTHORIZE GRANT EXPENDITURES

WHEREAS, the U.S. Department of Justice awarded Waukesha County Edward Byrne Memorial Justice Assistance Program Grant funds for the purpose of enhancing law enforcement, and

WHEREAS, these funds became available in 2005, with the grant expiring in 2008, and

WHEREAS, use of these grant funds was delayed until 2006 and were not included in the 2006 adopted budget.

THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY DOES ORDAIN that the Waukesha County Sheriff's Department be authorized to accept \$11,281 for the 2005 Department of Justice Edward Byrne Memorial Justice Assistance Program Grant for the purchase of hand held mobile radios.

BE IT FURTHER ORDAINED that the Sheriff's Department 2006 budget be modified by increasing inter-governmental revenues by the amount of \$11,281, and authorizing the appropriation of \$11,281 by increasing related operating budget expenditure accounts for identified expenditures under the grant.
