

ENROLLED ORDINANCE 161-29

AMEND THE WAUKESHA COUNTY CODE OF ORDINANCES TO PROHIBIT
BRINGING DANGEROUS ITEMS INTO THE COURTHOUSE
AND ADMINISTRATION CENTER

WHEREAS it is appropriate and imperative for Waukesha County to provide a safe and secure work place for its employees and citizens as they conduct governmental business, and

WHEREAS the current Waukesha County Code of Ordinances does not prohibit bringing dangerous items into the Courthouse and Administration Center.

THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY DOES ORDAIN
AS FOLLOWS:

SECTION 1. Section 3.3 of the Waukesha County Code of Ordinances shall be created to read:

No person, except for law enforcement officers who are on duty at the time, will be permitted admittance to the Waukesha County Courthouse and Administration Center if they are found to have in their possession any item that, in the discretion of security personnel, could pose a danger to the safety and security of persons working and conducting governmental business in the courthouse and administration buildings.

SECTION 2. Section 3.4 of the Waukesha County Code of Ordinances shall be created to read:

Unless otherwise authorized the following list of items will not be permitted in the Courthouse and Administration Center:

- a) firearms
- b) ammunition
- c) explosives
- d) knives
- e) pellet guns
- f) replica firearms
- g) box cutters
- h) razor blades

Security personnel are authorized to use discretion to deny entry to individuals in possession of items not included on the above list if they believe the item(s) could pose a danger to the safety and security of persons working and conducting governmental business in the courthouse and administration buildings.

SECTION 3. This ordinance shall be effective upon approval and publication.


SECTION 4. The provisions of this ordinance shall be included and incorporated in the Code of Ordinances of the County of Waukesha, Wisconsin, as an addition or amendment thereto and shall be appropriately renumbered to conform to the numbering system contained therein.


SECTION 5. Any code section or part of a section in conflict with this ordinance is hereby repealed and declared null and void and of no effect.






