

ENROLLED ORDINANCE 161-39

ACCEPT WISCONSIN OFFICE OF JUSTICE ASSISTANCE  
DIGITAL RECORDING PROGRAM GRANT (2006)

WHEREAS, the State of Wisconsin Office of Justice Assistance awarded Waukesha County Digital Recording of Custodial Interrogations Program Grant funds to assist law enforcement agencies in conforming with the 2005 Wisconsin Supreme Court decision ordering state law enforcement agencies to make audio recordings of all juvenile interviews/interrogations, and

WHEREAS, these funds became available in 2006, with the grant expiring at the end of 2006.

THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY DOES ORDAIN that the Waukesha County Sheriff's Department be authorized to accept \$11,035 for the 2006 state of Wisconsin Office of Justice Assistance Digital Recording of Custodial Interrogations Program Grant for the purchase of hand held digital voice recorders and to equip an interview room for both voice and visual recording.

BE IT FURTHER ORDAINED that the Sheriff's Department 2006 budget be modified by increasing inter-governmental revenues by the amount of \$11,035, and authorizing the appropriation of \$11,035 by increasing related operating budget expenditure accounts for identified expenditures under the grant.
