

ENROLLED ORDINANCE 161-40

MODIFY PENSION CONTRIBUTIONS FOR NON-REPRESENTED, NEW EMPLOYEES

WHEREAS the County has historically paid non-represented employees' share of the Wisconsin Retirement System pension contribution after six (6) months of employment, and

WHEREAS pension contributions are a significant component of an employee's total compensation paid by the County, and

WHEREAS it is anticipated that having non-represented employees who are hired after January 1, 2007 pay a portion of the pension costs will have a long term savings effect.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that all regular full-time and regular part-time non-represented employees hired as new employees or rehired as employees on or after January 1, 2007 will contribute one percent (1%) of wages toward the employee share of the Wisconsin Retirement System during their entire term of employment with Waukesha County; the provisions of this ordinance shall not apply to any regular hired employee prior to January 1, 2007 who is continuously employed by the County and who is promoted, demoted or transfers to another County position on or after January 1, 2007.
