

ENROLLED ORDINANCE 161-46

DESIGNATE DEPARTMENT OF HEALTH AND HUMAN
SERVICES AS CHAPTER 55 ADULT-AT-RISK AGENCY

WHEREAS Chapter 55 of the Wisconsin State Statutes governs protective services and placements for adults who are in need of care because of complications of aging, developmental disabilities or other physical and mental conditions, and

WHEREAS Chapter 55 was revised with an effective date of November 1, 2006, and

WHEREAS section 55.043, Wis. Stats., newly created by the revision, requires county boards to designate an adult-at-risk agency for receiving, investigating and responding to reports of abuse, neglect or self-neglect of adults at risk, and

WHEREAS the Department of Health and Human Services currently functions in this capacity, making that department the logical choice for designation as the adult-at-risk agency for Waukesha County.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that, in accordance with section 55.043, Wis. Stats., the Waukesha Department of Health and Human Services is designated as the adult-at-risk agency for Waukesha County for purposes of receiving, investigating and responding to reports of abuse, neglect or self-neglect of adults at risk living or located in Waukesha County.


