

ENROLLED ORDINANCE 161-61

REPEAL SECTIONS 6-32, 6-33 OF THE WAUKESHA COUNTY CODE OF  
ORDINANCES REGARDING THE ESTABLISHMENT OF FEES FOR  
THE WAUKESHA COUNTY SHERIFF'S DEPARTMENT

WHEREAS the Waukesha County Sheriff's Department (WSD) annually sets fees for Huber inmate daily board and bag lunch costs in the county budget process, and

WHEREAS WSD also sets annual fees for municipal inmates being housed in the County jail in the county budget process, and

WHEREAS section 6-32 of the Waukesha County Code of Ordinances also sets the fees for municipal inmates, and

WHEREAS section 6-33 of the Waukesha County Code of Ordinances also sets the fees for daily Huber board, and

WHEREAS these fees are set in the county budget, and then the Code of Ordinances must be changed by ordinance as well to allow the fees to be charged.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES  
ORDAIN that sections 6-32 and 6-33 of the Waukesha County Code of Ordinances are repealed.


