

ENROLLED ORDINANCE 161-74

ACCEPT FUNDS FROM BUREAU OF AERONAUTICS AND APPROPRIATE  
REVENUE IN 2007 BUDGET FOR PURCHASE AND INSTALLATION  
OF CONTROL TOWER RADIOS

WHEREAS, Waukesha County Airport is part of the United States Contract Tower Association,  
and

WHEREAS, the County is responsible for the operation and maintenance of the control tower  
and certain equipment, and

WHEREAS, the current radios used for communicating with both airborne and ground traffic are  
over 20 years old, and

WHEREAS, maintenance and repair has become increasingly difficult due to the age of the  
radios and availability of parts, and

WHEREAS, the purchase of control tower communication radios is eligible for federal and state  
funding, and

WHEREAS, the Wisconsin Bureau of Aeronautics has allocated \$37,000 in state and federal  
funds for the purchase and installation of control tower communication radios.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS  
that the Waukesha County Airport is authorized to accept \$37,000 from the Wisconsin Bureau of  
Aeronautics for the purchase and installation of control tower communication radios.


BE IT FURTHER ORDAINED that the Airport 2007 Operating budget be modified by
