

ENROLLED ORDINANCE 161-82

CREATE PARKLAND MANAGEMENT COST CENTER IN THE WALTER J. TARMANN  
FUND AND AMEND WAUKESHA COUNTY CODE OF ORDINANCES TO  
CREATE AN EXEMPTION TO THE COUNTY DONATION POLICY

WHEREAS the Waukesha County Board has adopted a Park and Open Space Plan for Waukesha County with the latest version approved on March 23, 2004, and

WHEREAS the Waukesha County Board created, through enrolled ordinance 150-28, a special revenue fund known as the Walter J. Tarmann Park Land Acquisition Fund to account for funds donated and dedicated for parkland acquisition, and

WHEREAS the Department of Parks and Land Use has been preparing parkland management plans which will guide future development and maintenance of the parks, and

WHEREAS the Department of Parks and Land Use consistently receives inquiries regarding the ability to accept donations for the management of parklands, including requests to accept donations to satisfy land mitigation requirements as part of development projects, and

WHEREAS Chapter 7 of the County Code includes provisions for "Acceptance and Use of Cash and Noncash Donations."

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that a new cost center be established in the Walter J. Tarmann Fund in fiscal year 2007 to account for donations for the purpose of parkland management, with investment revenue allocated to the unexpended balance, and

BE IT FURTHER ORDAINED that Section 7-91 (c) 3. is created to read as follows:

Donations of funds made to the Parkland Management cost center in the Walter J. Tarmann Fund shall not be subject to sections 7-89, 7-90 or 7-91 (a)1, and can be accepted by the county without further action.

BE IT FURTHER ORDAINED that donations received for this purpose will be appropriated through separate County Board action or through the annual budget process.

BE IT FURTHER ORDAINED that this ordinance shall be effective upon approval and publication.

BE IT FURTHER ORDAINED that the applicable provisions of this ordinance shall be included and incorporated in the Code of Ordinances of the County of Waukesha, Wisconsin, as an addition or amendment thereto and shall be appropriately renumbered to conform to the numbering system contained therein.


BE IT FURTHER ORDAINED that any code section or part of a section in conflict with this ordinance is hereby repealed and declared null and void and of no effect
