ACCEPT 2006 STATE OF WISCONSIN DEPARTMENT OF TRANSPORTATION TRACS
PROJECT GRANT AND MODIFY WAUKESHA COUNTY SHERIFF DEPARTMENT'S
2007 BUDGET TO AUTHORIZE GRANT EXPENDITURES

WHEREAS, the State of Wisconsin Department of Transportation, in cooperation with the U.S. Department of Justice made grant funds available to counties to fund development of interfaces between local automated records management systems and the state's Traffic and Criminal Software (TraCS) system that provides automated citation and accident information and reporting, and

WHEREAS, these grant funds became available after the 2007 budget process had been completed, and

WHEREAS, this grant will be used in conjunction with state grant funds received in 2006 to increase the effectiveness of the TraCS system by funding in-car printers to produce hard copy citations and accident reports from the automated TraCS data, and

WHEREAS, grant funds were available only to a consortium of police agencies, not to a single one.

THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY DOES ORDAIN that the Waukesha County Sheriff's Department be authorized to accept a Department of Justice federal grant of \$25,908 to fund purchase and implementation of in-car printers to produce hard copy documents from data generated through the state TraCS system.

BE IT FURTHER ORDAINED that the Sheriff's Department 2007 budget be modified by \$25,908 by increasing inter-governmental revenues by the amount of \$25,908, and authorizing the appropriation of \$25,908 by increasing the department's operating expenditure appropriation budget accounts to cover costs associated with the project.
