MODIFY WAUKESHA COUNTY UNIVERSITY OF WISCONSIN EXTENSION
OFFICE 2008 BUDGET TO APPROPRIATE FUNDING RECEIVED FROM
THE UNIVERSITY OF WISCONSIN SYSTEM TO SUBCONTRACT
FOR THE HUNGER AND FOOD INSECURITY PROJECT

WHEREAS the Board of Regents of the University of Wisconsin System has authorized the Waukesha County University of Wisconsin Extension office to complete a Hunger and Food Insecurity project by analyzing local school data, creating a final report to present to Waukesha County Nutrition Coalition partners and community organizations and further develop resources as identified in a recent survey to educate Waukesha County low income residents, and

WHEREAS the County UW-Extension Office received funding from the Board of Regents of the University of Wisconsin System to subcontract work for this project, and


WHEREAS the County UW-Extension Office received these funds for this project in a prior year but did not appropriate this funding in their budget, therefore the funds lapsed to the general fund balance and need to be appropriated in order to accomplish the project requirements.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County University of Wisconsin Extension office is authorized to appropriate \$21,293 of funding received from the Board of Regents of the University of Wisconsin System in order to complete a Hunger and Food Insecurity project.


