

ENROLLED ORDINANCE 162-104

EXPENDITURE OF SEIZED FUNDS AMEND 2008 SHERIFF'S DEPARTMENT
BUDGET MULTIPLE EXPENDITURE REQUESTS

WHEREAS, enrolled ordinance 141-41 authorizes the Sheriff's Department "... to participate in the program to transfer federally seized property to local enforcement agencies," and

WHEREAS, the Sheriff's Department has such assets that were not allocated during the 2008 budget process, and

WHEREAS, the Department has identified expenditures to enhance law enforcement in Waukesha County as required by federal seized asset guidelines, and

WHEREAS, department estimates of the costs for the enhanced law enforcement expenditure items may vary considerably.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the Waukesha County Sheriff's Department 2008 Budget be modified by appropriating seized assets received in 2007 (and reserved in general fund balance) by an amount not to exceed \$251,217 and authorize the appropriation of an identical amount between Operating Expense and Fixed Asset appropriation based on actual expenditures made in accordance with the attached detailed list of law enforcement enhancement items.

BE IT FURTHER ORDAINED that the modifications to the 2008 budget appropriations authorized by this ordinance shall be made by the county's Department of Administration as the exact expenses are identified, not to exceed a total of \$251,217.
