APPROVE LAND USE PERMIT TO WISCONSIN ELECTRIC POWER COMPANY
FOR CONSTRUCTION, OPERATION, AND MAINTENANCE OF UNDERGROUND
ELECTRIC POWER LINES IN THE TOWN OF SUMMIT – LAKE COUNTRY TRAIL

WHEREAS it is deemed desirable to allow the Wisconsin Electric Power Company installation, operation and maintenance of underground electric power lines within Waukesha County property located in Section 24, Township 7 North, Range 17 East, Town of Summit, Waukesha County, Wisconsin, and

WHEREAS it is necessary to provide a Land Use Permit from Waukesha County to the Wisconsin Electric Power Company in order that underground electric power lines can be constructed, and


WHEREAS the Wisconsin Electric Power Company has agreed to provide Waukesha County an easement for the extension of the Waukesha County Lake Country Trail, and

WHEREAS in consideration of said easement it is desirable to waive the normal Land Use Permit Fee of \$1147.00.






