

ENROLLED ORDINANCE 162-127

APPROVE CONTRACT WITH MILWAUKEE COUNTY TO PROVIDE SHORT TERM
MEDICAL EXAMINER ASSISTANCE

WHEREAS, Waukesha County has entered into many cooperative agreements with other governmental bodies to coordinate resources and provide assistance in times of emergency, and

WHEREAS, the Milwaukee County Medical Examiner's office has recently experienced the loss of several pathologists who will not be easy to replace, and

WHEREAS, Milwaukee County has contacted Waukesha County to determine if the Waukesha County Medical Examiner's office can assist with cases, including autopsies and investigations, on a short term basis, and

WHEREAS, staff in the Waukesha County Medical Examiner's office are willing to assist in exchange for increased compensation, and

WHEREAS, Milwaukee County is willing to compensate the County for the use of their staff and to enter into a contract ensuring that no Waukesha county resources will be utilized for the Milwaukee County cases, and

WHEREAS, the contract between the counties will not extend beyond six months and will guarantee that Waukesha County Medical Examiner staff will be assigned a mix of cases based on complexity, and

WHEREAS, Waukesha county work will receive priority status by the Medical Examiner's staff involved in this cooperative effort.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the cooperative agreement between Milwaukee County and Waukesha County, which provides assistance to the Milwaukee County Medical Examiner's office and will compensate Waukesha County and the Waukesha County employees assisting Milwaukee County, on file in the office of the Department of Administration, is approved and may be executed by the County Executive.

BE IT FURTHER ORDAINED that the Medical Examiner 2008 budget be modified by increasing Charges for Service revenue appropriation unit \$267,120 and increasing Personnel cost appropriations by \$267,120.

BE IT FURTHER ORDAINED that the Waukesha County Medical Examiner and pathologist shall receive increased compensation, in calendar year 2008 only, for any work performed for Milwaukee County pursuant to the contract between the counties.
