

ENROLLED ORDINANCE 162-14

ESTABLISH SALARY FOR COUNTY BOARD SUPERVISOR

WHEREAS the Waukesha County Code of Ordinances states that County Board Supervisors shall receive a salary as determined by the County Board, and

WHEREAS Enrolled Ordinance 151-105, adopted on February 25, 1997, indicated that prospective salaries for elected officials should be established on a rational basis by approximating cost-of-living adjustments received by county employees in prior years for comparable periods, and

WHEREAS non-represented employees received across-the-board increases of 3.0% in 2006 and 3% in 2007, and

WHEREAS, comparable to increases for non-represented employees, the salary for County Board Supervisors could be adjusted accordingly; however, the Personnel Committee recommends that salaries be frozen at present levels for the next term of office.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the salary for the County Board Supervisor shall be as follows:

1. Effective the first pay period following the third Tuesday in April 2008, the salary for County Board Supervisor shall be \$366.77 bi-weekly (\$9,536 annually).
2. Effective the first pay period following the third Tuesday in April 2009, the salary for County Board Supervisor shall be \$366.77 bi-weekly (\$9,536 annually).
