

ENROLLED ORDINANCE 162-30

ACCEPT ARCh DONATION

WHEREAS, The Association for the Rights of Citizens with handicaps (ARCh) promotes the health, safety and achievement of children and adults with disabilities, and

WHEREAS, since 1959 Camp Pow Wow, operated by ARCh in Menomonee Park, has been providing outdoor recreational opportunities for adults and children with disabilities, and

WHEREAS, Camp Pow Wow uses a swing set as part of their recreational programming, and

WHEREAS, the swing set that was removed in spring 2007 from Camp Pow Wow at Menomonee Park because it was no longer in compliance with current safety standards , and

WHEREAS, ARCh staff have chosen to donate a swing set, wood fiber surfacing, and installation of the swing set and wood fiber to replace the old swing set, and

WHEREAS, the value of the swing set, surfacing and installation is \$5,469.00.


