

ENROLLED ORDINANCE 162-31

LAYING OUT, RELOCATION AND IMPROVEMENT OF COUNTY TRUNK
HIGHWAY Q - PROJECT I.D. 02-2751(13)(C) COLGATE ROAD TO CTH Y
VILLAGE OF MENOMONEE FALLS, WAUKESHA COUNTY

WHEREAS the County Board of Supervisors of Waukesha County finds that the proper improvement in maintenance of the above County Trunk Highway in the Village of Menomonee Falls from the Northeast corner of the Northwest One-Quarter of Section 6, Town 8 North, Range 20 East, Village of Menomonee Falls, Waukesha County Wisconsin to appoint that is 3.93 feet South of and 1,189.81 feet West of the Southeast Corner of Section 31, Town 9 North, Range 20 East, Village of Germantown, Washington County, State of Wisconsin, requires certain relocation or changes and the acquisition of certain rights of way as shown on the plat marked "Plat of Right of Way Required for CTH Q, Project I.D. 02-2751(13)(C), CTH Q, Colgate Road to CTH Y, Waukesha County."


