

ENROLLED ORDINANCE 162-50

APPROVAL OF SOUTHEAST HANGAR AREA PHASE II DEVELOPMENT
RATES AND CHARGES AND HANGAR CONSTRUCTION STANDARDS

WHEREAS on May 9th the Airport Commission approved hangar construction covenants and a standard land lease for development in the southeast hangar area phase II; and

WHEREAS on July 11th the Airport Commission approved a 2007 land lease rate for that area, as well as an adjustment mechanism.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that land lease rates for development in the southeast hangar area phase II be \$.34 per square foot for 2007, adjusted by the Consumer Price Index (CPI) each year thereafter.


