

ENROLLED ORDINANCE 162-58

AUTHORIZE WAUKESHA COUNTY SHERIFF TO CONTRACT
FOR POLICE SERVICES WITH THE TOWN OF LISBON

WHEREAS the Town Board of the Town of Lisbon and the Waukesha County Sheriff's Department have arrived at a contractual agreement for the Sheriff's Department to provide police services to the Town of Lisbon, and

WHEREAS Waukesha County has the opportunity to hire two (2) former Town of Lisbon police officers who are certified, trained, and upon successful completion of the County's employment process, will be on the current civil service eligibility list.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the contract for services on file with the Waukesha County Sheriff which sets forth the agreement for the Waukesha County Sheriff's Department to provide police services to the Town of Lisbon, to commence at the beginning of the calendar year 2008, is hereby approved.

BE IT FURTHER ORDAINED that the Department of Administration, with full approval and consultation of the Personnel Committee, is authorized to prepare and provide a benefit package which will recognize the training and length of service of full-time Town of Lisbon police officers during their transition of employment to Waukesha County, which package shall be no more beneficial than the contract with current County employees.
