

ENROLLED ORDINANCE 162-59

APPROPRIATE STATE OF WISCONSIN DIVISION OF PUBLIC HEALTH
WOMEN, INFANT AND CHILDREN NUTRITION PROGRAM 2007
GRANT FUNDING INCREASES TO THE WAUKESHA COUNTY
DEPARTMENT OF HEALTH AND HUMAN SERVICES

WHEREAS, nutrition-related health programs continue among Waukesha county infants, children and pregnant women, and

WHEREAS, the Women, Infant and Children Program (WIC) provides nutritional prescriptions and monetary food vouchers to resolve these current or potential nutrition related health problems, and

WHEREAS, the State of Wisconsin Division of Public Health, 2007 WIC Grant allocation was received in March 2007 in the amount of \$356,011, which is \$14,099 above the \$341,912 included in the adopted 2007 Public Health Division budget, and

WHEREAS, the State of Wisconsin Division of Public Health allocated to the County an additional \$9,723 in August of 2007 to support WIC Program activities, and

WHEREAS, the total State of Wisconsin Division of Public Health, 2007 WIC Grant budget net allocation amount totals \$365,734 to offset expenditures associated with WIC Program operations, and

WHEREAS, this ordinance seeks to modify the 2007 adopted budget by appropriating the additional funding allocation of \$23,822 to equal the \$365,734 of state WIC Grant funding.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the Department of Health and Human Services, Division of Public Health be authorized to accept and appropriate the additional grant funds allocated for the Women, Infant and Children Program by the State of Wisconsin, Department of Health and Family Services, Division of Public Health.

BE IT FURTHER ORDAINED that the 2007 Department of Health and Human Services, Public Health Division budget be modified by increasing general government revenues by \$23,822 and increasing personnel cost appropriations for temporary extra help by \$3,026, operating expense appropriations by \$10,099 and additional interdepartmental charge appropriations by \$10,697 for costs associated to the Women, Infant and Children Program.
