

ENROLLED ORDINANCE 162-83

ESTABLISHMENT OF SPEED ZONE – CTH VV

WHEREAS Wisconsin Statutes permit local authorities to establish speed zones within certain guidelines.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the speed zone on CTH VV in the Town of Merton is modified as follows:


Fifty (50) miles per hour on CTH VV from a point 0.15 miles West of Center Oak Road westerly to a point 275 feet east of its intersection with Champion Run Drive.


Forty-five (45) miles per hour on CTH VV from a point 275 East of Champion Run Drive to a point 0.35 miles East of STH 83.


BE IT FURTHER ORDAINED that this declaration rescinds all previous restrictions for the above-described portion of the County Trunk Highway System.






