

ENROLLED ORDINANCE 162-86

ACCEPT GATES FOUNDATION SPANISH LANGUAGE OUTREACH PROGRAM
GRANT AND MODIFY THE 2007 FEDERATED LIBRARY BUDGET TO
APPROPRIATE GRANT REVENUES AND EXPENDITURES

WHEREAS, the Gates Foundation has awarded Waukesha County Federated Library System with a \$5,700 grant, as administered by the State Department of Public Instruction, to increase the knowledge and skills of public library staff to better serve technology needs of Spanish speakers in the community, and

WHEREAS, the funds will be used on a one time basis to provide library staff in Waukesha County and surrounding library systems with training so that they are better able to serve Spanish speaking patrons, and

WHEREAS, the Gates Foundation Spanish Language Outreach Program Grant provides the funds necessary for staff to attend training and to hold three outreach workshops for library staff, and

WHEREAS, due to the timing of the grant receipt, the Waukesha County Federated Library System requests that any unexpended grant funds and revenues be carried over to modify the 2008 Federated Library System budget.

THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY DOES ORDAIN that the Waukesha County Federated Library System be authorized to accept \$5,700 of Gates Foundation grant funding.

BE IT FURTHER ORDAINED that the Waukesha County Federated Library System 2007 budget be modified by \$5,700 by increasing Operating expense appropriations by \$5,700 and Library Grant revenue by \$5,700.


