

ENROLLED ORDINANCE 163-101

ELIMINATE TRANSIT TRANSFER FEE AND ZONE FARE
CHARGES ON MASS TRANSIT SYSTEM

WHEREAS the County operates a mass transit system using contracts with public and private transit providers, and

WHEREAS several of the County routes are extensions of or otherwise connect to routes operated by other governmental units in southeastern Wisconsin, and

WHEREAS the ease and convenience of transferring between transit systems is seen as a key component in increasing mobility and access to employment for riders, and

WHEREAS past experience has shown that transfer fees and zone fare charges to riders passing between Milwaukee and Waukesha Counties is a barrier and disincentive to increasing ridership, and

WHEREAS the increased ridership resulting from the elimination of the transfer and zone fees is expected to generate additional revenue to at least offset the reduction in revenues from this policy change, and

WHEREAS the County Executives of Waukesha County and Milwaukee County, along with the Mayor of the City of Waukesha, have embraced the concept of increasing transit ridership by eliminating barriers to usage of all three transit systems.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Transit Transfer fee and Zone fare are eliminated on Routes 1, 10 and 218 in Waukesha County.


