

ENROLLED ORDINANCE 163-69

APPROVE 2009 SALARIES FOR NON REPRESENTED EMPLOYEES

WHEREAS it is necessary to maintain an appropriate and competitive salary system and structure to attract and retain non represented employees, and

WHEREAS it is also appropriate to consider the increases granted to represented employees when establishing the non represented salary increases, and

WHEREAS the 2009 labor agreements provide represented employees with an increase of 2% in January and a 1% increase in July.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN the following changes in salary structure for Non Represented employees for 2009

Section I The following modifications will be applied to Salary Ranges S-1 through S-11; O-7 through O-12; Non-4 and Non-5; IS-01 through IS-02A, and TMP-32.

A. Effective January 3, 2009 an across the board increase of 2.5% will be applied.

Section II The following modifications will be applied to Salary Ranges O-13 through O-15, O-20, O-24, IS-3 through IS-16, and Non-01 through Non-03.

A. Effective January 3, 2009 an across the board increase of 2% will be applied.

Section III The following modifications will be applied to Salary Ranges O-16 through O-19.


A. Effective January 3, 2009 an across the board increase of 1.75% will be applied.

Section IV The following modifications will be applied to the remaining non represented seasonal and temporary salary ranges. Effective January 3, 2009 an across the board increase of 2% will be applied.


