

ENROLLED ORDINANCE 163-82

MODIFY 2009 AIRPORT OPERATING BUDGET FOR SPECIAL ASSESSMENT
BY THE CITY OF WAUKESHA FOR SANITARY SEWER

WHEREAS, the City of Waukesha installed sanitary sewer around the airport property along Pewaukee and Bluemound Roads and a pump station at the intersection of said roads, and

WHEREAS, the City Common Council, under Sec. 66.0617, Wis. Stats., is enabled to enact an ordinance to impose impact fees in order for public facilities to pay their fair share of municipal capital costs, and

WHEREAS, Chapter 4.10 of the Waukesha Municipal Code permits special assessments be levied, and

WHEREAS, the assessments were deferred until the border adjustment with the City of Pewaukee was enacted, and

WHEREAS, the border adjustment became effective January 1, 2008, and

WHEREAS, the City of Waukesha has issued a special assessment, in the amount of \$33,288 for the extension of a sanitary sewer under Pewaukee Road to potentially serve portions of the southeast hangar area of the airport, and


WHEREAS, a second special assessment was made in the amount of \$34,605 for the north ramp area and is levied only for those structures for which connections are actually made, and

WHEREAS, two hangars in the north ramp have connected to the sanitary service making those frontages subject to the special assessment.


THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY DOES ORDAIN that the Airport 2009 Operating budget be modified by increasing operating expenses by \$67,900 to pay the special assessment and other revenues shall be increased by transferring \$67,900 from Airport fund balance.
