ACCEPT U.S. MARSHAL'S OFFICE FUNDS TO PURCHASE HIDTA EQUIPMENT
AND MODIFY WAUKESHA COUNTY SHERIFF DEPARTMENT'S
2009 BUDGET TO AUTHORIZE THESE EXPENDITURES

WHEREAS, the U.S. Marshal has requested that the Waukesha County Sheriff's Department act as a fiduciary for the Marshal's southeastern district in acquiring certain equipment for the High Intensity Drug Traffic Area (HIDTA) program in southeastern Wisconsin, and

WHEREAS, these grant funds became available after the 2009 Sheriff's budget process had been completed, and

WHEREAS, the Department has long maintained an excellent working relationship with the Marshal's office and desires to agree to this request, and

WHEREAS, these funds require a fiduciary agency other than the Marshal to make the expenditures.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Sheriff's Department be authorized to make expenditures, not to exceed \$15,000, on behalf of the U.S. Marshal to fund the purchase of equipment to be used by the southeastern Wisconsin HIDTA task force.

BE IT FURTHER ORDAINED that the Sheriff's Department 2009 budget be modified by increasing intergovernmental revenues by \$15,000, and increasing the department's operating and/or Fixed Asset expenditure appropriation units by up to \$15,000 to cover costs associated with the project.
