

ENROLLED RESOLUTION 163-2

RECOGNIZING SEPTEMBER 10 – OCTOBER 10 AS VOTER
REGISTRATION MONTH IN WAUKESHA COUNTY

WHEREAS, the right of American citizens to vote is guaranteed by the United States and Wisconsin Constitutions, and

WHEREAS registering empowers us to vote on Election Day, upholding the basis of democracy with one voice, one vote and,

WHEREAS, Wisconsin law and the Help America Vote Act of 2002 requires that everyone register prior to voting, and while most Waukesha County citizens are currently registered to vote, an additional 22,000 people are eligible to vote but have not yet registered and,

WHEREAS, registered voters who have a changed address or name must fill out a new registration application, and,


WHEREAS, because of the large number of expected voters at the November 4, 2008 election for President, Congress, the state legislature, and county officials, registration lines at the polls could be long, so early registration before October 10 will make the voter process faster and more efficient.


NOW THEREFORE BE IT RESOLVED BY THE WAUKESHA COUNTY BOARD OF SUPERVISORS that September 10, 2008 through October 10, 2008 shall be recognized as voter registration month in Waukesha County.






